GUARANTEE/WARRANTY

- Guarantee/warranty for items, machine ,mechanical parts & control system shall be for a period of years starting from the date of satisfactory installation, commissioning and handing over of the whole machine. “After sales service” and replacement of any parts of the equipment or rectification of defects of the equipment and software updates shall be free of cost from the

supplier's end during the guarantee/warranty period. The warranty period should include at least 2 preventive maintenance per year. The supplier should attend the complaints within 3 working days from the receipt of communication from the customer.

2. The supplier shall attend to and repair or replace the defect of non-performance of equipment detected or reported to the supplier by buyer during the period of Warranty, free of any additional cost to the buyer.
3. The Purchaser shall promptly notify the Supplier in writing of any claims arising under this warranty. Upon receipt of such notice, the Supplier shall arrange to repair or replace the defective goods or parts within 3 days free of cost in SIDCO. The Supplier shall take over the replaced parts/goods at the time of their replacement. No claim whatsoever shall lie on the Purchaser for the replaced parts/goods thereafter. The period for correction of defects in the warranty period is 3 days. If the supplier having been notified fails to remedy the defects within 03 days, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expenses and without prejudice to any other rights, which the purchaser may have against the supplier under the contract. The maintenance charges (CMC) under different schemes after the expiry of the warranty should also be clearly mentioned with the tender documents. The comprehensive warranty will commence from the date of the satisfactory installation/commissioning of the equipment against the defect of any manufacturing, workmanship and poor quality of the components. After the warranty period is over Comprehensive Maintenance Contract (CMC) up to next five years should be started. The CMC charges will not be included in computing the total cost of the equipment. Any failure to rectify the machine faults, the amount incurred shall be deducted from BG or EMD amount

MACHINE/ITEMS CONSTRUCTION, DELIVERY, INSTALLATION, ERECTION & COMMISSIONING:

1. The machine /items should be delivered at site within 60 days on receipt of purchase order. Failing of which Liquidated Damage as per the laid down procedure will be imposed on the supplier.
2. The supplier has to complete the commissioning work within 1 month from the date of completion of erection work, failing of which Liquidated Damage as per the laid down procedure will be imposed on the supplier.
3. While commissioning of hardness tester 03 no's of test pieces will be produced on machine .
4. If after delivery, acceptance and installation and within the guarantee and warranty period, the operation or use of the goods proves to be unsatisfactory, the Purchaser shall have the right to continue to operate or use such goods until rectifications of defects, errors or omissions by repair or by partial or complete replacement is made without interfering with the Purchaser's operation. The supplier is required to do the installation and demonstration & training of the equipment within 1 month of the arrival of machine at the SIDCO site of installation, otherwise the penalty clause will be the same as per the supply of materials.
5. The supplier should ensure the quality; time-bound delivery, supply and installation of the products/execution of works at customer site, after sale services, etc.

6. Any kind of quality complaints, if noticed, will be made good from the supplier bill or from any other amount due to the bidder from the Corporation or through other means which the Corporation thinks fit, including Revenue Recovery. It is the duty of supplier to prove that they have not caused any quality complaints of the product/execution of work, delivered to the customers of the Corporation.
7. The supplier shall ensure all industry standard security measures regarding the security of the system such as data security, network security etc.

Quality of Material

1. All consumables, electrical and electronic parts of the product conform to international standard(s) or Bureau of Indian Standards.

Training

Training must be provided to the 2 staff members after the delivery of the machine at our site in the following aspects introduction, Basic instructions, Operation of the Machine, Application and mechanical and Electrical Maintenance including safety. Etc.

GENERAL TERMS & CONDITIONS OF TENDER

1. The Machine/items are procuring only for commercial purpose and not for any training course. Hence the machine should be suitable for the exact purpose.
2. Every tender shall be made in English. Tender should be free from overwriting. All corrections and alterations should be duly self-attested by the tenderer.
3. The bidders shall sign and seal in all pages of the Tender Notice and Tender documents.
4. Bidder should have an authorized service center.
5. The bidder should clearly mention the validity of the offer and time required for Supply, Installation and commissioning of machinery as per specification.
6. Financial bids of those who technically qualified alone will be evaluated.
7. The rates furnished by bidders shall be inclusive of statutory duties, all taxes, transportation, training, installation, commissioning, delivery and installation all other charges applicable.
8. The tenderer shall provide in its tender the required as well as the relevant documents like technical data, literature, drawings etc. to establish that the goods and services offered in the tender fully conform to the goods and services specified in the tender documents. For this purpose the tenderer shall also provide a clause-by-clause commentary on the technical specifications and other technical details incorporated in the tender documents to establish technical responsiveness of the goods and services offered in its tender. In case there is any variation and/ or deviation between the goods & services prescribed by SIDCO and that offered by the tenderer, the tenderer shall list out the same in a chart form without ambiguity along with justification, and provide the same along with its tender. If a tenderer furnishes wrong and/ or misleading data, statement(s) etc. about technical acceptability of the goods and services offered by it, its tender will be liable to be ignored and rejected in addition to other remedies available to SIDCO in this regard.
9. The successful bidder has to execute an agreement as per the format specified in ANNEXURE-V (After award of Contract) Along with the tender, a preliminary agreement in stamp paper worth Rs.200/- is to be executed by the contractor as per the model agreement approved by Corporation. Tenders will not be considered without this agreement. Earnest money of a tenderer will be forfeited, if the tenderer withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender. The successful tenderers earnest money will be forfeited if it fails to furnish the required performance bank guarantee within the specified period.
10. Bidder should confirm that there would not be any price escalation during the supply period. And we will abide by all the e-tender terms and conditions and we do not have any counter conditions.

11. Risk Purchase Clause: In event of failure of supply of the item/equipment within the stipulated delivery schedule, the purchaser has all the right to purchase the item/equipment from the other source on the total risk of the supplier under risk purchase clause.
12. **Right to Use Defective Goods:** If after delivery, acceptance and installation and within the guarantee and warranty period, the operation or use of the goods proves to be unsatisfactory, the Purchaser shall have the right to continue to operate or use such goods until rectifications of defects, errors or omissions by repair or by partial or complete replacement is made without interfering with the Purchaser's operation. The supplier is required to do the installation and demonstration & training of the equipment within 4 weeks of the arrival of materials at the SIDCO site of installation, otherwise the penalty clause will be the same as per the supply of materials. In case of any damage to equipment and supplies during the carriage of supplies from the origin of equipment to the installation site, the supplier has to replace it with new equipment/supplies immediately at his own risk. Supplier will settle his claim with the insurance company as per his convenience. SIDCO will not be liable to any type of losses in any form.
13. All the terms and conditions in respect of warranty/guarantee, Training of Staff etc mentioned in Section IV shall be complied with.
14. **Technical Specifications and Standards:-** The Goods & Services to be provided by the successful tenderer under this contract shall conform to the technical specifications and quality control parameters mentioned in this document.
15. The tenderer shall be responsible for payment of any charges due to any statutory authorities such as Income Tax, CGST, SGST, IGST, Customs Duties etc.
16. If the customs duty, CGST, SGST and IGST are left blank, then it will be considered as zero (inclusive in the basic price) or not applicable and BOQ will be considered for evaluation.
17. In the event, if it found that there is some statutory deduction to be made at the source, the Tender Inviting Authority will have the authority to do so.
18. Once the tender has been accepted, the bidder will be liable to supply the products/execute the works to the destinations as per the Purchase/Work Order within the time stipulated for delivery.
19. The items supplied against the tender must strictly conform to the specifications as prescribed in tender. If there is any variation in the specification of the product supplied the same has to be replaced.
20. The assurance of quality, time bound supply, delivery and installation of the products/ execution of works at customer site will be the sole responsibility of the bidder and they should ensure the same.
21. Transporting of materials to the site will be responsibility of the supplier and hence the prices shall be inclusive of transportation charges .
22. An agreement has to be executed between Kerala SIDCO and the successful bidder within seven working days after publishing the Award of contract in stamp paper.
23. By submitting the bid it is presumed that the bidder has verified the tender documents and technical

specification of the items in details and has quoted the tender rate accordingly.

24. The bidder should agree and give an undertaking that they will give onsite support through their local office/service/support center/ arrangement in Kerala and keep it operational till the duration of warranty.
25. The assurance of quality, time bound delivery, supply and installation of the products/execution of works at customer site, after sale services, including loading unloading etc. will be the sole responsibility of the bidder and they should ensure the same.
26. The Successful bidder on award of Purchase/work order based on the tender, has to return a copy of the same to SIDCO duly signed and sealed.
27. If the bidder fails to honor the Purchase/Work Order or fails to deliver the products/execution of works in time, the Corporation will make its own arrangement for supplying the products/execution of works at the cost of the bidder. If the Corporation incurs any loss in this account, the amount will be recovered from the bidder.
28. SIDCO will be doing final inspection for product/work supplied/delivered and shall reject the material at the cost of supplier in case of quality/specification complaint. The rejected goods are to be removed from supply point at the expense of supplier and materials should be replaced within time limit as intimated by SIDCO.
29. Quality Complaints: Any kind of quality complaints, if noticed, will be made good from the bidder's bill or from any other amount due to the bidder from the Corporation or through other means which the Corporation thinks fit, including Revenue Recovery. It is the duty of successful bidder to prove that they have not caused any quality complaints of the product/execution of work, delivered to the customers of the Corporation.
30. The corporation will in no way indemnify against any eventualities arising out of low quality of products/work/service and punishments by the legal/statutory authorities due to negligence, willful act on the part of the bidder or his representative engaged by the bidder. All such issues are to be solved by the Bidder at his own risk.
31. Disputes: All disputes in this regard, if any, will be settled by Arbitration. The venue of the Arbitration will be either in Thiruvananthapuram or Ernakulam. The Arbitrator will be appointed by the Managing Director of Kerala SIDCO Ltd. and the law will be Indian law and language will be in English.
32. Those who have been terminated or black listed by Govt. / Kerala SIDCO will not be able to participate in this tender.
33. Following documents are to be presented by the successful bidder for payment after Supply:
- Triplicates of invoices,
 - Temporary Permit Documents

- Insurance Documents.

34. The tender will be considered firm for acceptance for a period of 180 Days and the tenderers will not be free to withdraw or modify their tender within this period or till after the tenders are decided, whichever is earlier.
35. SIDCO shall make payment to successful bidder. No interest is paid to bidder for belated payments due to non-supply or delay on the commissioning as per the e tender.
36. The Earnest Money Deposit will not bear any interest.
37. In case of stoppage of work due to dispute with the contractor or due to any other reasons the owner will have the right to take over the site and will have right to make alternative arrangements for construction without causing any delay.
38. The Managing Director, Kerala SIDCO reserves the right to accept or reject the tender/tenders without assigning any reason thereof.
39. All conditions in Notice inviting Tenders, Tender document will form part of the agreement.
40. The tenderer is expected to visit the site and study the probable routes of transportation of material/machine to the site before quoting.
41. The tenderer has to agree and strictly abide to all the conditions stipulated in the tender and any offer with deviation or request for deviation is liable to be rejected.
42. Defects if any noticed within 3 years from the date of completion, will have to be rectified by the contractor.
43. Acceptance / Rejection of tenders: It is also not necessary that the offer of the firm quoting the lowest rates shall be accepted. Usually the lowest offers of tenderers qualified for the price bid opening shall be accepted, unless one sided conditions unacceptable to the Tender Inviting Authority are provided in such price bid.
44. At any point of time, the Tender Inviting Authority reserves the right to cancel or modify the supply order even after it is awarded to the successful tenderer in the event the firm deviates from the agreed terms and conditions.
45. Strictly ensure that the item supplied meets tender specification as per annexure I and in good quality otherwise same will be rejected.
46. Amendment of tender documents: At any time prior to the dead line for submission of tender, the Tender Inviting Authority may, for any reason, modify the tender document by amendment.
47. The amendments shall be published in e-tender portal, and the tender shall submit copy of amendments published if any signed by the tenderer or the authorized representative shall be enclosed as part of the technical bid as a proof of having read and accepted the terms and conditions of the tender document.

48. The Tender Inviting Authority shall not be responsible for failure to inform the prospective tenderers for any notices published related to each tender. Tenderers are requested to browse e- tender portal or website of the Tender Inviting Authority for information/general notices/amendments to tender document etc on a day to day basis till the tender is concluded.

SPECIAL CONDITIONS

1. The rates quoted should be for the delivery at sites mentioned in documents and the rates quoted must be firm, for the period of 180 days from the date of offer.
2. The quantity mentioned there in approximate requirement and in case of SIDCO requires more/less quantity the supplier should be prepared to effect supply at short notice at the agreed rate and terms and condition in the tender.
3. Machine with lowest L1 rate will be considered from amount the technically qualified bidders and tender shall be evaluated on item wise basis only.
4. The supplier agrees to supply strictly as per the order request terms in respect of quantity and quality and will be free from defects in material.
5. Supply of Item should be completed before the time stipulated by the corporation failing which the corporation will procure the item from other sources at the risk and cost of the bidder.
6. If bidder is unable repair, as applicable, a defective product which is covered by manufacture Warranty, manufacturer shall within a reasonable time after being notified of the defect, refund the purchase price of the product.
7. The supplier should provide the details of the service centers available with details.
8. If the products supplied are not as per the specifications. In the tender; it will be summarily rejected and may result in black listing the Vendor.
9. The supplier must provide the after sale service within warranty period whenever applicable. Warranty card from OEM/Authorized dealer must be submitted.
10. Loss of Property: If any type of loss made by supplier or its staff, then it will be the sole responsibility of the supplier.
11. The bidder shall be a manufacturer, if not; the supplier shall produce the manufacturer Letter of

Authorization in the prescribed form. See Annexure VI.

12. The bidder should agree and give an undertaking that they will give onsite support through their local office/service/support centre/ arrangement in Kerala and keep it operational till the duration of warranty. The warranty should be comprehensive on site.
13. Defective Equipment: If any of the equipment supplied by the Supplier is found to be substandard, refurbished, un-merchantable or not in accordance with the description/specification or otherwise faulty, the SIDCO will have the right to reject the equipment or its part. The prices of such equipment shall be refunded by the Supplier with 18% interest if such payments for such equipment have already been made. All damaged or unapproved goods shall be returned at suppliers cost and risk and the incidental expenses incurred thereon shall be recovered from the supplier. Defective part in equipment, if found before installation and/or during warranty period, shall be replaced within 10 days on receipt of the intimation from this office at the cost and risk of supplier including all other charges. In case supplier fails to replace above item as per above terms & conditions SIDCO may consider "Blacklisting" the supplier and take legal actions against them.
14. Termination for Default (i) The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Supplier, terminate the Contract in whole or part:
15. If the Supplier fails to deliver any or all of the Goods within the period(s) specified in the order, or within any extension thereof granted by the Purchaser; or
 - I. If the Supplier fails to perform any other obligation(s) under the Contract.
 - II. If the Supplier, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract
 - III. The bidder shall be responsible for any loss/ damage to material during transportation to the designated location.
16. The successful Bidder shall, within a week from the date of receipt of communication of acceptance of quotes from purchaser shall intimate his acceptance of the order. The successful bidder shall complete supplies strictly as per the accepted delivery period.
17. Bidder should agree to impart onsite training to the designated personnel of purchaser for stipulated no. of working days decided in consultation with the tenderer.
18. In case of tenders for multi items or single item with multi consignees, the criterion for evaluation of tenders deciding inter se position of the tenderers will be item wise and / or consignee wise and not on total value as a whole, unless otherwise specified in the tender, which may please be noted.

19. 4. 5% shall be released after warranty period (3 years) or against unconditional bank guarantee, and successful training. (Applicable only for ROCKWELL HARDNESS TESTER)

Performance Security

Performance Security in the form of Bank Guarantee (BG) on the prescribed format @5 % of order value in favor of Kerala SIDCO, valid for 36 months from the date of successful completion of installation and commissioning at site or 5 % amount can be withheld in lieu of Performance Security.

Spare parts

1. Successful tenderer shall carry sufficient inventories to assure ex-stock supply of consumable spares for the goods so that the same are supplied to the Tender Inviting Authority/User Institution promptly on receipt of order from the Tender Inviting Authority/User Institution.
2. The successful tenderer shall take over the replaced parts/goods after providing their replacements and no claim, whatsoever shall lie on the Tender Inviting Authority for such replaced parts/goods thereafter.
