ELIGIBILITY CRITERIA OF TENDERERS

1. The tender is in two bid system viz Technical and Financial
2. The bidder have to submit the tenders in 2 covers, superscribing our tender no and Tender name in a sealed cover and should reach this office by hand or through speed post/courier on or before the date mentioned above. The Tenders shall be submitted as specified below:
3. The bidder may visit the worksite for more clarification if required before participating in the tender. Contact details of TOOL ROOM HEAD are furnished for further clarifications regarding the tender.
4. The Successful Bidder should be delivered the equipment as per the tender within 14 days on receipt of purchase order. Failing of which Liquidated Damage as per the laid down procedure will be imposed on the supplier.
5. The supplier has to complete the installation & commissioning work within 7 days from the date of completion of Delivery, failing of which Liquidated Damage as per the laid down procedure will be imposed on the supplier.
6. The rates quoted by the bidder are inclusive of Basic Price, Transportation, all taxes, Incidental Services (including Insurance, Loading/ Unloading, Packing & Forwarding charges Installation, Commissioning, Demonstration, Training etc.
7. The Cat 6 cable required for installing the Camera System, Networking, and Intercom Facility has already been installed. At present, only the cost of the equipment for the CCTV Camera System, Networking, and Intercom Facility, and the cost for installation and commissioning of the same, are to be quoted in the tender.

- ii) Bids exceeding the PAC limits are liable for outright rejection

ADDITIONAL CLAUSE – COMPLIANCE WITH MEITY NOTIFICATION (CCTV CAMERAS)

Compliance with MeitY Notification on CCTV Cameras

1. The CCTV cameras supplied under this tender shall strictly comply with the applicable notifications, orders and guidelines issued by the Ministry of Electronics and Information Technology (MeitY), Government of India, including amendments issued from time to time.
2. Only CCTV cameras manufactured by MeitY-notified manufacturers and registered under the MeitY Mandatory Testing and Certification / Trusted Source / Conformity Assessment framework, as applicable, shall be accepted.
3. The bidder shall submit along with the Technical Bid:
4. The bidder shall ensure that the CCTV equipment:
 - a) Does not contain any prohibited or insecure hardware, software, firmware or backdoors,
 - b) Supports secure user authentication, password policy and access control,
 - c) Allows firmware updates only from authorised sources.
5. In case, at any stage, the supplied CCTV cameras are found non-compliant with MeitY notification or Government of India security requirements, the entire system shall be replaced by the bidder at no extra cost to SIDCO, and such non-compliance shall be treated as breach of contract.
6. The bidder shall indemnify Kerala SIDCO Ltd. against any loss, penalty, security risk or legal implication arising due to non-compliance with MeitY regulations.
7. No payment shall be released for CCTV items unless MeitY compliance documents are verified and accepted by SIDCO.

WARRANTY CLAUSE (STANDARD – 2 YEARS)

1. The contractor shall provide a comprehensive warranty for a period of Two (2) Years / Twenty-Four (24) Months from the date of satisfactory installation, commissioning and handing over of the Camera System, Networking and Intercom Facility.
2. During the warranty period, the contractor shall, at their own cost, repair or replace any defective parts, components, equipment or software and rectify any faults arising due to manufacturing defects, poor workmanship or material failure, without any additional cost to Kerala SIDCO Ltd.
3. The warranty shall include all labour, spare parts, transportation and on-site support required to keep the system in full working condition.

GENERAL TERMS & CONDITIONS OF TENDER

- 1) Every tender shall be made in English. Tender should be free from overwriting. All corrections and alterations should be duly self attested by the tenderer.
- 2) **The Successful bidder should furnish agreement in the prescribed format ANNEXURE-IV (To be furnished in Rs.200 stamp paper by successful bidder only after the award of work order)**
- 3) The Successful Bidder should submit Copy of Aadhar Card,Copy of Bank Pass Book,Copy of Election ID Card of Company representative,Latest Photo(Passport Size) of Company representative,Mobile Number of Company representative, and also if the organisations registered as Private Limited Company then the Successful bidder has to submit Articles of Memorandum of association, Details of Company Directors, Registrars of Companies Certificate Etc along with the agreement document after the award of work order.
- 4) Tenders forwarded through e-mail or open cover will not be entertained.
- 5) Tenders sent without two Cover system is liable to be rejected.
- 6) Tenders received after the due date will not be considered.
- 7) Financial bids of those who technically qualified alone will be evaluated.
- 8) Guarantee/Warranty/Free Service details shall be furnished (Copy of the same in letter head of firm/manufacturer has to be enclosed). Authorisation letter regarding Manufactures warranty, shall also be furnished.
- 9) In case of electronic goods/computer system and peripherals copy of the onsite warranty certificate copy from the manufacturer has to be submitted to Corporation.
- 10) The rates furnished by bidders shall be inclusive of statutory duties, all taxes, transportation, delivery and installation charges if applicable (Taxes & Charges has to be clearly shown separately in the Financial Bid).
- 11) The successful bidder has to execute an agreement as per the format specified in ANNEXURE –IV (After award of Contract).
- 12) Once the tender has been accepted, the bidder will be liable to supply the products/execute the works to the destinations as per the Purchase/Work Order within the time stipulated for delivery.
- 13) The items supplied against the tender must strictly conform to the specifications as prescribed in tender. If there is any variation in the specification of the product supplied the same has to be replaced.

14)Statutory deductions shall be recovered from the work bill as per prevailing rules.

15)The tender should be valid for a period of three months from the date of opening of tender

16)Transporting of materials to our customer site will be responsibility of the supplier and hence the prices shall be inclusive of transportation charges which has to be shown separately.

17)An agreement has to be executed between Kerala SIDCO and the successful bidder within seven working days after publishing the **Award of contract**.

18)By submitting the bid it is presumed that the bidder has verified the tender documents and technical specification of the items in details and has quoted the tender rate accordingly.

19)The bidder should agree and give an undertaking that they will give onsite support through their local office/service/support centre/ arrangement in Kerala and keep it operational till the duration of warranty.

20)The assurance of quality, time bound delivery, supply and installation of the products/execution of works at customer site, after sale services etc. will be the sole responsibility of the bidder and they should ensure the same.

21)The Successful bidder on award of Purchase order based on the tender, has to return a copy of the same to SIDCO duly signed and sealed.

22)If the bidder fails to honor the Purchase/Work Order or fails to deliver the products/execution of works in time, the Corporation will make its own arrangement for supplying the products/execution of works at the cost of the bidder. If the Corporation incurs any loss in this account, the amount will be recovered from the bidder.

23)SIDCO will be doing final inspection for product/work supplied/delivered and shall reject the material at the cost of supplier in case of quality/specification complaint. The rejected goods are to be removed from supply point at the expense of supplier and materials should be replaced with in time limit as intimated by SIDCO.

24)Quality Complaints: Any kind of quality complaints, if noticed, will be made good from the bidder's bill or from any other amount due to the bidder from the Corporation or through other means which the Corporation thinks fit, including Revenue Recovery. It is the duty of successful bidder to prove that they have not caused any quality complaints of the product/execution of work, delivered to the customers of the Corporation.

25) The corporation will in no way indemnify against any eventualities arising out of low quality of products/work/service and punishments by the legal/statutory authorities due to negligence, wilful act on the part of the bidder or his representative engaged by the bidder. All such issues are to be solved by the Bidder at his own risk.

26) Disputes: All disputes in this regard, if any, will be settled by Arbitration. The venue of the Arbitration will be either in Thiruvananthapuram or Ernakulam. The Arbitrator will be appointed by the Managing Director of Kerala SIDCO Ltd. and the law will be Indian law and language will be in English.

27) Those who have been terminated or black listed by Govt. / Kerala SIDCO will not be able to participate in this tender.

28) Samples and specimens has to be provided as per the tender requirement wherever necessary.

29) The rate offered must be valid for 90 days.

30) The tender will be considered firm for acceptance for a period of 90 DAYS and the tenderers will not be free to withdraw or modify their tender within this period or till after the tenders are decided, whichever is earlier.

31) Defects if any noticed within 24 months from the date of supply, will be got rectified by the bidder.

32) SIDCO shall make payment to successful bidder. No interest is paid to bidder for belated payments from customer department.

33) The Earnest Money Deposit will not bear any interest.

34) The managing director /Head – Production Infrastructure / Regional Operation Head, Head Tool room cum Training Centre Kerala SIDCO reserves the right to accept or reject the tender/tenders without assigning any reason thereof.

Liquidated Damages

1. In the event of supplier's failure to have the Camera System, Networking and Intercom Facility or any part thereof delivered by the date/dates specified in the contract, the purchaser may at his discretion withhold any payment until the whole of the Camera System, Networking and Intercom Facility have been supplied and the purchaser may also deduct from the supplier as agreed ,Liquidated Damages and not

by way of penalty ,the sum of 0.5% of the contract price of the delayed supplies for each week or part of a week for which delay has occurred, subject to maximum of 15 % of the value of delayed supplies.

2. For delay in completion of any works or services attributable to the supplier, which leads to delay in commissioning and final acceptance of the Camera System, Networking and Intercom Facility LD will be imposed @ 0.5% of the Full contract price of the Camera System, Networking and Intercom Facility for each and every week and part of a week of delay in commissioning and final acceptance, subject to maximum of 15 % of the full contract price. This LD will be in addition to the LD against delay in delivery of supplies.
3. Liquidated Damages shall be calculated on the contract value exclusive of GST.
4. LD shall be levied for the period for which the supplier was responsible for the delay in delivery / execution i.e. LD shall be waived if the reasons for delay are not attributable to the supplier.

Payment & Performance Security

1. 95% payment shall be made against delivery, installation, commissioning and successful training of the CCTV Camera System, Networking and Intercom Facility.
2. The balance 5% retained shall constitute the sole Performance Security, valid for 24 months from the date of successful installation and commissioning.
