Quotations are invited from Qualified individuals who is having qualification from a recognized art institution for acrylic canvass painting in the work "Interior furnishing of proposed passenger lounge at International Cruise terminal, Ernakulam".

Scope of work

Art work style: Traditional arts of Kerala.

The work includes acrylic paintings representing traditional arts of Kerala of size 0.95 m x 1.20 m (12 nos) and 0.95 m x 1.20 m (7 nos).

The requirements and conditions are furnished below.

- The work should be carried out in Cement board/ Hard board with panel, with thickness not less than 10 mm.
- This work includes application of one or more layer of acrylic wall primer of superior quality suitable for interior/exterior conditions.
- Drawing of acrylic painting based on themes that represent traditional arts of Kerala should be done only after getting approval from the client department upon submission of the theme for the painting through proper channel .
- The painting should be Hand-painted and should not be aided by the help of modern printing techniques/machineries
- This work includes a protective coating of UV resistant clear protective finish over the finished work.
- The tenderer should have a minimum experience of 5 year in this specific field. (Certificates of the same should be submitted).
- There will be a scrutiny for the tenderer to ensure the quality of work.
- There will not be any advance payment provided for this specific work.
- After the successful completion of the work, the payment will be released from the Tourism Department (Client department) as per the recommendation from SIDCO Ltd.
- The time allotted for the completion of work is 3 months from date of handing over the site.

- SIDCO Ltd. have the whole authority to cancel/rearrange the tender procedures if needed.
- The defect liability period for the painting will be five years.
- The person undertaking the painting work should visit the site to assess the requirements for installation and make the necessary arrangements to secure it in place.
- The painting should be placed only after framing.
